**AGREEMENT TO REIMBURSE KEWASKUM FOR PROFESSIONAL STAFF SERVICE FEES**

Pursuant to the Village of Kewaskum Municipal Code, the Village Board has made a determination that whenever the services of the Village’s Planner, Engineer, Attorney, or any other of the Village’s professional staff results in a charge to the Village for that professional’s time and services, and such service is not a service supplied to the Village as a whole, the Village Treasurer shall invoice the Property Owner for those fees incurred by the Village. Fees are charged on an hourly basis, or portion thereof, at a rate that is in effect at the time the professional service is performed. Also be advised that pursuant to the Village of Kewaskum Municipal Code, certain other fees, costs, and charges are the responsibility of the Property Owner or Responsible Party **even if the request is not approved.** Imposition of any fees, costs, or charges, however, is subject to the Property Owner’s appeal rights as described in the Village of Kewaskum Municipal Code.
